 - Two points from Chris: As of May 31 Compass is 91% of the way through the year and has received 92% of revenue. Compass is on track to be under budget at the end of the year. The audit will confirm this.

FY20 Budget Review

Shifts in the budget since the last meeting:

• The decision around teacher's salary and providing the extra support for teachers made a lot of difference. This budget reflects current teacher salaries. We have an 80% teacher

- retention rate and an 83% administrative staff retention rate. Marcia thanked Denise for her good work building relationships with the staff.
- The last week of school we learned that distribution of mill funding shifted for Compass. We are earmarking these dollars as we see where enrollment lands and how many students are on IEPs (might need to hire another part time or full-time specialist).
- 10k gift from the Margulf Foundation has been added into the budget.
- Bob asked for a detailed estimate on mill dollars. Chris clarified that it was roughly \$120k.
- Jess thanked Marcia for getting the budget out early and for their hard work. She also shared that it was great to be able to honor the teachers.
- Chris asked for the board chair's signature.
- Marcia thanked Chris.

5. Strategy discussion

Innovation Zone

- Zone conversation Mary met with Susana. Susana is open to a conversation around collaboration, learning, and family of schools. Mary emphasized that Compass wants to partner with the district in a purposeful way. Susana connected Mary with Amy Keltner, Deputy Chief of Schools. Mary talked to Amy about the various paths: conversion to a district school, innovation zone, etc. Discussed meeting with Transcend partner as well. Amy suggested a facilitated design conversation to see what the opportunities might be. Gates Family Foundation could be a funder of this work.
- Jim asked about what variation of Innovation is Compass exploring?
 - Marcia shared that the lead idea is a mixed zone of charter and district schools. Still open.
- Next move: Marcia to meet with District leaders to talk about collaboration. She may reach out to the Lincoln leader, Antonio Esquibel, to learn more about their direction. Morris shared that City Year might be at Lincoln next year.
- Question: What is the status of the SPF? There have been some shifts. But not a lot is going to change for this year. They had close to 200 applicants (including Marcia) to be on the SPF task force that will discuss future shifts.
- November Board elections is something to watch as we partner with the District Facility
 - Facility Search Thanks to City Year for their incredible relationship with TransWestern. They added many thoughtful layers of data, e.g., poverty density, average drive time for students, and Spanish speaking density, to name just a few. They also explored land and structure opportunities. Marcia and TransWestern staff toured different properties. Marcia reviewed several properties (see Power Point).
 - Question: Is Loretto Heights still a contender? If we could make it work, it is still the number one choice. The Walmart property is also a contender.
 - Leasing is still an option.
 - Jess shared that we are in exploratory phase and will continue to the facility conversation as we see the results of the middle school.
